RECRUITMENT OF ONE (01) INDIVIDUAL CONSULTANT TO DEVELOP A DIRECTIVE FOR THE HARMONIZATION OF REGULATIONS ON SUSTAINABLE MANAGEMENT OF HEALTHCARE WASTE IN WEST AFRICA

Introduction

The West African Health Organisation (WAHO), a specialised institution of ECOWAS, has received grants from the World Bank for the implementation of several projects (**REDISSE**, **SWEDD**, **SM/NTD** and **WA-MRH**) and intends to use part of this grant to make payments under the following contract: "Recruitment of one (01) Individual Consultant to Develop a Directive for the Harmonization of Regulations on Sustainable Management of Healthcare Waste in West Africa".

Overarching Objective of the Mission

The main objective of the mission is to develop a regional directive for the harmonization of regulations on sustainable management of healthcare waste in West Africa.

Specific Objectives

More specifically, the consultant shall:

- Carry out an exhaustive analysis of the laws and regulations relating to the management of healthcare waste in various ECOWAS countries and Mauritania,
- Identify the strengths and weaknesses of countries' legal frameworks,
- List the various areas to be strengthened,
- Propose a draft ECOWAS Directive on sustainable management of healthcare waste,
- Support WAHO in the organisation of the regional workshop to validate the Directive.

The consultant shall propose a methodological approach including a broad involvement of stakeholders and partners, a pre-validation meeting of the draft Harmonization Directives and a regional validation workshop.

Mission Commencement Date and Duration

The mission will start in September for an estimated duration of four months.

Consultant's Profile

The lead consultant in charge of developing the Directives for the Harmonization of Legislation on Sustainable Management of Healthcare Waste in West Africa must have at least the qualifications defined below:

- Must hold a Master's degree in law (public law or international law),
- Must have experience in the field of environmental law,

- Must have sound knowledge of environmental legislation and in particular the legal framework relating to the management of healthcare waste,
- Must have sound knowledge of the health system in the countries of the ECOWAS region,
- Must have participated in at least two (2) legislative harmonization processes in West Africa in the field of health /environment,
- Must have experience in drafting legislative and regulatory texts,
- Must have excellent capacity for analysis and synthesis and reports writing skills,
- Must have knowledge of the countries in the region,
- A good command of one of the three ECOWAS languages (English, French and Portuguese), Proficiency in a second language would be an asset.
- Must have good knowledge of computer for data processing and data analysis.

The lead expert will propose Expert No 2 with a master's degree in environmental sciences or medicine with a specialization in public health. The complete profile of Expert No 2 is given in the Terms of Reference available on WAHO website: <u>w3.wahooas.org.</u>
